 - Nicole motions to move accounts to CIBC due to the VISA debit option. Mandy seconds and the vote is yes.

 - Mandy motioned to purchase 1 more spotlight from AV Shop. Sandra seconds and vote is yes. Shelly will order 1 more spotlight.
 - It was mentioned that the sound system is not working right in the main arena. Shelly will email Krista regarding this, as well as any other options for more storage area for costumes and supplies.
 - Find a home for the bingo paper! That will free up a lot of room.
